

## How to purchase a cash register online?


For Purchasing the product, first step is to successfully register and log-in into your profile. Without registering and logging-in you cannot be able to buy the product. After you are successfully registered and logged-in your profile you can go to **Products** section in the menu, choose the cash register that you would like to buy and click on **ADD TO CART** button.



After clicking the **ADD TO CART** button, a window will show up noting "The product has been successfully added to cart", click on **Go to Cart** button, after which you will be automatically redirected to the **CART**.



After going to **CART**, you can see the cash register that you added into cart. For purchasing it, you have to go through several steps indicated on the picture: 1. In the box where is written number 1, choose the city and indicate the valid address of the place at which you are going to use the cash register (you can click on the red question mark symbol which is marked in yellow and see the information provided). 2. Then choose the subscription (you can click on the red question mark symbol which is marked in yellow and see the information provided). 3. Afterwards click on the button marked with number 3. 4. Then, in the box where is written number 4, choose the city and indicate the valid address where you need the product to be delivered. Also, indicate the valid phone number so our operator can contact you. 5. After filling all the valid data and previous four steps, you can click **Buy** button which is marked with number 5. Our operator will reach you via phone number you indicated and you will get the cash register and the contract on the address you indicated very soon.



**NOTE:** PLEASE CONSIDER, THAT IN ORDER TO START USING THE CASH REGISTER, THE DIRECTOR/OWNER OF THE COMPANY OR THE PERSON WHO HAS THE POWER OF ATTORNEY HAS TO SIGN THE OFFICIAL CONTRACT. OUR COURIER WILL BRING THE CONTRACT TOGETHER WITH CASH REGISTER. PLEASE, AT THE TIME WHEN THE DELIVERY WILL COME, BE AT THE PLACE AND SIGN THE CONTRACT, SO COURIER CAN BRING THE SIGNED CONTRACT BACK TO OUR COMPANY FOR CONFIRMATION. IF THE CONTRACT IS SIGNED BY PERSON WHO HAS THE POWER OF ATTORNEY, TOGETHER WITH THE CONTRACT THE POWER OF ATTORNEY PAPER SHOULD BE ALSO SENT TOGETHER WITH THE CONTRACT.

IN CASE IT IS AN EMERGENCY AND THE CONTRACT IS NOT SIGNED IMMEDIATELY, OUR COURIER WILL LEAVE THE CONTRACT AND AFTER IT IS SIGNED, PLEASE, CALL DHL-GEORGIA AND INFORM THEM ABOUT DELIVERY OF CONTRACT TO GEORGIAN SERVICE NETWORK. IF IT IS SIGNED BY PERSON WHO HAS POWER OF ATTORNEY, TOGETHER WITH THE CONTRACT THE POWER OF ATTORNEY PAPER SHOULD BE ALSO SENT. (PLEASE, NOTE THAT ALL THE EXPENCES OF CONTRACT DELIVERY WILL BE COVERED BY GEORGIAN SERVICE NETWORK).

PLEASE NOTE, THAT WHITHOUT SIGNING THE CONTRACT YOU WILL NOT BE ABLE TO USE THE CASH REGISTER OR SUPPORT AND WARRANTY CONTRACTS.
